TRAVEL PROTECTION PLAN

WAIVER OF THE PRE-EXISTING MEDICAL CONDITION EXCLUSION

The exclusion for Pre-Existing Condition can be waived provided:

- a. Your plan cost and enrollment form is received within the Time Sensitive Period; &
- b. You are medically able and not disabled from travel at the time Your plan cost is paid based on assessment of a Physician.

Program Cancellation: If you cancel your program for a covered reason prior to the scheduled departure date, we can reimburse you, up to the maximum benefit amount shown in the schedule of benefits, for the unused, forfeited, prepaid non-refundable payments or deposits for the program arrangements you purchased for your program.

Program Interruption: If you must start your program late or are unable to complete your program due to a covered reason, we can reimburse you up to the maximum benefit amount shown in the schedule of benefits for unused, forfeited, prepaid non-refundable payments or deposits paid for the land or water program arrangements you purchased for your program plus the additional transportation cost paid to: a) join your program if you must depart after your scheduled departure date or travel via alternate travel arrangements; or b) rejoin your program from the point where you interrupted your program to the next scheduled destination; or c) transport you to your originally scheduled return destination of your program.

Program Delay: Reimburses up to the maximum benefit amount shown in the schedule of benefits for the unused, forfeited, prepaid non-refundable payments or deposits for the travel arrangements, reasonable additional expenses, plus the additional transportation cost paid to join/re-join your trip or be transported back to your final destination if your trip is delayed at least 6 consecutive hours from the original departure time and this prevents you from reaching your scheduled destination.

Medical Evacuation and Repatriation of Remains: Among other things, this reimburses transportation expenses incurred to transport you to the nearest medical facility where treatment is available if you incur a sickness or injury that is acute or life-threatening during your trip and adequate treatment is not available in your immediate area.

Optional Cancel for Any Reason (CFAR): If you cancel your trip for any reason not otherwise covered by this plan, benefits may be reimbursed up to 75% of the trip cost provided your payment/deposit for this plan is received within the time sensitive period, and you must cancel the trip 48 hours or more before scheduled departure date of your trip. Additional costs and terms apply.
